### **CANCELLATION POLICY**

Cancellation for all tours are subject to a charge of \$300CAD. Should you cancel within 60 days of departure, the **Land Price** is *non-refundable*.

The **Air Price** *cancellation charge* is;  
60 days or less before departure 10%  
30 days or less before departure 25%  
14 days or less before departure 50%  
7 days or less before departure 100% of ticket price  
*Notice of cancellation is required in writing.*

*RBC CANCELLATION and MEDICAL INSURANCE* is available to BC residents only. Rates are based on age, health and time away. Prices available on request.

We encourage clients to cover at least the Land Price with a cancellation policy. *This insurance must be purchased at the time of your deposit.*

## **THE FINE DETAILS**

**CANCELLATION FEE** If you cancel your reservation more than 60 days before departure your deposit will be forfeited. If your cancellation is received within 60 days of the start of the tour the full Land Price, including the deposit, is not refundable.

**CANCELLATION INSURANCE** We strongly recommend the purchase of cancellation insurance. By paying the required premium at the time of booking you will be covered against all nonrefundable cancellation charges. The policy covers reimbursement up to the amount of the insurance purchased of all non-refundable costs of your tour if you are prevented from departing, or unable to complete the tour after departure because of jury duty, quarantine, accident, sickness or death to yourself or your travelling companion, or sickness or death to someone in your family. No benefits are payable if you have to cancel because of injuries while participating in an athletic competition or demonstration (professional or amateur), gliding, mountaineering, speed or racing contests, skydiving or parachuting. Insurance must be purchased at the time deposit is made.

**RBC TRAVEL INSURANCE** - available to British Columbia residents only.

**BAGGAGE ALLOWANCE** 2 bags are allowed with a maximum combined weight of 20 kg. for international travel. Bags are at owners risk throughout the tour. No responsibility is incurred for loss, theft, or damage to baggage or any of the passenger's belongings. Baggage insurance is available.

**BOOKING INFORMATION** A *non refundable* deposit of \$750CAD is required with your registration plus trip cancellation insurance premium. Medical insurance may be purchased any time prior to departure. The balance is due 60 days before departure. A release of liability is required.
